

Pet Care Agreement & Release of Liability

By registering my Pet as a Boarding, Daycare, Training and/or Grooming Guest at **Boxers Bed & Biscuits**, I certify that I have read, understand and agree that **Boxers Bed & Biscuits** (its staff, owners, contractors and agents collectively) will not be liable for any problems, damage, or injuries caused by my Pet during its stay at **Boxers Bed & Biscuits**. I, the Pet Owner (or Owner's Authorized Representative if setting up the account through a Boxer's Staff Member), agree to be solely responsible for any/all acts of behavior of my Pet while in the care of **Boxers Bed & Biscuits**. I hereby release **Boxers Bed & Biscuits** from any liability arising from my Pet's attendance and participation in the Pet Hotel group-play environment.

_____ I understand and agree that in admitting my Pet to **Boxers Bed & Biscuits**, the Pet Hotel Staff have relied on my representation that my Pet is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other Pet of its kind.

_____ I hereby certify that my Pet is in good health and has not been ill with any communicable diseases or illnesses in the 30 days prior to check-in. If my Pet becomes ill or injured while staying at **Boxers Bed & Biscuits** and requires medical treatment, as determined by Pet Hotel Staff, **Boxers Bed & Biscuits** will make every attempt to contact me or my emergency contacts and/or my veterinarian for further instruction. If the illness or injury appears to be life-threatening, as determined by Pet Hotel Staff, my Pet will be seen by one of our veterinarians on site. I also understand that such emergency veterinary expenses shall be reimbursed by me directly to **Boxers Bed & Biscuits** upon check-out.

_____ I understand that **Boxers Bed & Biscuits** is a facility for friendly, non-aggressive Dogs that play well in groups. The **Boxers Bed & Biscuits** secondary location (BRAT PACK)- located on Braun Road in Belpre, is a more traditional boarding environment where my Dog or Dog "Family" can play solo or in smaller groups- is also a facility for friendly, non-aggressive Dogs. I agree that if my Dog is deemed aggressive to staff, is unable to be handled, or unsafe for other Pets in our care, I will retrieve my Dog from said premises in a timely manner when notified by staff. The primary Pet Hotel on Washington Blvd. in Belpre is an open facility with all boarding, daycare and other play areas geared toward group play and group interaction. Although each Dog or Dog "Family" will be assigned its own hotel suite while boarding, I understand and agree that **Boxers Bed & Biscuits** strives for each Dog to spend most of their time in the company of Dog playmates at the Washington Blvd location. Private suites are only used for rest periods, naptimes, mealtimes and overnight rest for my Dog at either location. I understand and agree that if I have more than 1 pet and they are scheduled an overnight stay in a private suite together, at either location, and they are deemed by **Boxers Bed & Biscuits** to be aggressive or harmful to each other, these pets will be moved to separate suites for their stay and the charge for separate suites will be my responsibility. Cat Guests, however, will always remain in private suites, separate from other Cats that are not from their respective families.

_____ In group-play environments like **Boxers Bed & Biscuits**, I understand that Dogs play with mouths and feet (hence sharp teeth and nails) and Pets can sometimes sustain minor injuries. I recognize that Pet Hotel Staff will treat such minor injuries on site with general first-aid antiseptics. I also understand that Pet Hotel Staff may not notify me of these minor injuries until I pick up my Dog.

_____ I acknowledge that **Boxers Bed & Biscuits** is very similar to that of a children's daycare facility in that participants are happy to share everything from the pool to the drool so I am very aware of the potential spread of Canine Cough (Kennel Cough) since this illness thrives in any environment where Dogs congregate (dog parks, vet offices, grooming salons, kennels, etc.), regardless of the preventative measures taken by **Boxers Bed & Biscuits** to prevent the spread of this illness. I understand that Canine Cough is not usually serious and can go away on its own. However, I may choose to contact my veterinarian who may prescribe an antibiotic and a cough tab to remedy the illness more quickly. I understand that I am solely responsible for any tests and/or fees associated with treatment resulting from this common illness.

_____ Furthermore, I am aware that Canine Influenza is a potential risk, becoming more prevalent in the United States among Dogs, and it is spread more easily in environments where Dogs have direct contact with one another. I understand that while the Canine Influenza vaccine is required by **Boxers Bed & Biscuits**, if my dog isn't vaccinated upon the first visit for Canine Influenza I will be required to sign a waiver accepting the risks of not having this vaccine. I also understand that upon my next visit this vaccine will be required and must be obtained by my veterinarian for my Dog, Dogs(s) and documentation will be provided to **Boxers Bed & Biscuits**. I will not hold **Boxers Bed & Biscuits** liable for my Dog, Dog(s) possible contraction of Canine Influenza.

_____ I understand and agree that if my Dog, Dog(s), or Cat has been deemed unable to receive the vaccinations that **Boxers Bed & Biscuits** require, I am responsible for having documentation from my veterinarian office sent to **Boxers Bed & Biscuits** before any scheduled services. I also understand that I will be required to sign a release form acknowledging that my pet is under vaccinated and assume the risks involved and will not hold **Boxers Bed & Biscuits** liable for any contraction of any diseases.

_____ I understand and agree that if my Dog is exhibiting communicable disease symptoms; such as coughing, goopy eyes, or lethargy while boarding at either facility **Boxers Bed & Biscuits** will make every effort to contact me and my pet will be removed from group play until such arrangements can be made to have my Dog, Dog(s) picked up or seen by our veterinarians on site, at my expense, and quarantined.

_____ **Boxers Bed & Biscuits** agrees to due exercise and reasonable care for my Pet. Under the reasonable care of my Pet, **Boxers Bed & Biscuits** will put forth every effort to prevent illness/injury to my pet while in our care. In the occurrence such illness/injury occurs, I, as the Owner or Responsible Party, release **Boxers Bed & Biscuits**, the Pet Hotel, the staff, or any persons owning other Pets in the facility from any claim attributable to such illness or injury of Pet(s). I agree that I shall be responsible for all financial requirements that may occur due to said injury/illness for my pet. Also, I agree to indemnify **Boxers Bed & Biscuits** due to my failure to inform Pet Hotel Staff about my Pet's illness or aggression problems, which were otherwise caused by my Pet.

_____ If my Pet is transported by **Boxers Bed & Biscuits**, I will not hold **Boxers Bed & Biscuits** or its Staff responsible for any injury or accident during transportation. It is expressly agreed by me and the Pet Hotel that **Boxers Bed & Biscuits'** liability shall, in no event, exceed the lesser of the current chattel value of a Dog or Cat of the same breed or the sum of \$200 per Pet.

_____ I understand that if I leave my Pet at **Boxers Bed & Biscuits** for a period of 5 days beyond the scheduled ending date of its stay, my Pet will be considered abandoned, and necessary steps will be taken to turn the Pet over to the proper authorities.

_____ I understand and agree that if my Dog is at daycare at **Boxers Bed & Biscuits** and is not picked up by closing (7pm) my pet will be transferred into boarding and I will be responsible for fees associated, as well as I will be unable to pick up my dog until the following day.

_____ I understand and agree that if I do not notify **Boxers Bed & Biscuits** in reference to a boarding that was scheduled or a grooming appointment that was made within a 24/48 hour period prior to said reservation to cancel, a \$25 "no call no show" fee will be charged to my credit card on file or placed as a debit on my account that will be my responsibility to pay before any future services will be provided.

_____ By completing my Pet's online registration, I certify that I have carefully read and understand the policies of **Boxers Bed & Biscuits** as set forth in this document and that I have read, understand and agree to all the conditions and statements of this agreement.
